1 Introduction

This document publicly discloses the voting record of Perpetual Australian Equities (“PAEQ”), where Perpetual Investment Management Limited (“PIML”) is the investment manager of the Funds listed in the table below, for the period of 1 July 2024 to 30 June 2025 inclusive. Important information

PAEQ is an investment team within Perpetual Limited (“Perpetual”). Perpetual is an ASX-listed, diversified financial services company. Perpetual is a member of the Financial Services Council (FSC) and this disclosure complies with *FSC Standard No. 13: Voting Policy, Voting Record And Disclosure* (<https://fsc.org.au/resources/standards>).

Where possible, PAEQ does not apply different voting decisions to different equity portfolios (or “Funds”). To maximise the influence of our vote and for practical reasons, we vote consistently across all Funds where PAEQ retains the right to vote¹. This means that we apply the same voting decision taken on every (listed company meeting) resolution to our entire shareholding across these Funds.

It is for this reason that in this report, we exclude voting decisions on our discrete institutional equity mandates, as for these portfolios the voting decision is often taken by the client; and disclose voting decisions on an “Operator level” (i.e. PIML), rather than “entity and resolution level” (by individual portfolio). On this basis, only voting decisions taken on behalf of the following Funds are included in this report:
